Important: Read Carefully.

During the time required to heat your structure, the potential for damage to furnishings and fixtures is practically non-existent. The following precautions are suggested in order to protect items of a more delicate nature.

HEAT TREATMENT CHECKLIST

Articles that are impractical to remove may be wrapped with an insulating material or placed in the refrigerator.

Please remove from the treatment area the following items:

- People, plants, and pets. Fish and/or tanks must be removed from the residence prior to service.**
- Medicines and vitamins**
- Fresh fruits and vegetables, chocolates, wines, liquors, vitamins, medicines, and artificial sweeteners. Wax based or paraffin based items (i.e. make-up, lipstick, candles, wax figurines, crayons, etc.). In lieu of removal, small items may be placed in a refrigerator.**
- Antique furniture with finish or fragile glue points**
- Vinyl miniblinds and vinyl ceiling-mounted fan blades. Remove vinyl items where possible. Eliminate any vinyl or plastic under stress, including hanging picture frames, florescent light box lenses, etc.**
- Wooden and stringed musical instruments, but please leave the instrument cases.**

Prior to treatment, please complete the following:

- Unplug computers.**
- Picture frames assembled with hot-melt glue should be removed from the wall.**
- Clothing present during the heat treatment should be placed loosely in laundry baskets to allow the heat to penetrate.**
- Waterbeds must be drained and disassembled to allow the frame to reach the proper temperature. Airbeds must be partially deflated to avoid damage. Select Comfort style airbeds with an electric pump must be partially deflated and unplugged from outlet.**
- Turn on the heating system the morning of service or the night prior to service and set the thermostat to 90 degrees.**

It is the owner's or agent's responsibility to notify our company of the presence of the following items: Fire sprinklers and heat sensors. Also, please remove batteries from smoke detectors.
